

The Holy Spirit as an Advocate



When I was in sixth grade, I was in an advanced mathematics class that was *not* going well. On top of all of the stresses and feelings that came with being in sixth grade, I was struggling mightily with algebra. I enjoyed the elegance of math *when* it worked—but far too often, I couldn't make it work, and so I would get frus-

trated and stuck. I stopped doing the work and was rapidly getting behind.

What's worse was: I was terrified of my math teacher, who was (at least at Walter Stokes Middle School) infamously harsh and demanding of his students. I had no idea how to ask for help, let alone for an extension on the work that I hadn't done.

I hid what was happening from my parents for a while, but eventually the stress escalated and we needed to come up with a plan. I remember both the fear and relief I felt when my mother told me that she would go with me to the math teacher to advocate for me. Up until that moment, my young brain thought that I had to either sink or swim all on my own. In reality, I had an advocate who could help me.

As we are approaching Pentecost, I am thinking about the Holy Spirit. In John's gospel, Jesus calls the Holy Spirit "The Advocate." You'll hear this in our gospel lessons on May 25 and June 8. These gospels come from what is called "The Farewell Discourse." In this long conversation, his disciples ask him some pointed questions which prompt him to explain that, though he is going away, he will not leave them orphaned. He

promises that they will receive an Advocate, the Holy Spirit, who will guide them when he has gone away.

In the church we often think of the Holy Spirit in the way that Luke-Acts portrays her: a fiery, creative, powerful force that acts on the world. John, however, portrays the Holy Spirit as an Advocate, like a parent who goes with you when you have to face your own failures in front of a teacher who terrifies you.

And, this is not the only kind of advocacy that the Holy Spirit is up to—she is also an advocate for those who society has forgotten, disinherited, or thrown away. As we prepare for the feast of Pentecost in 2025, I find this image of the Holy Spirit both comforting and challenging.

What might it be like to face our limitations, failures, fears, or struggles knowing that God's own Spirit is our advocate? Who is the Holy Spirit advocating for in our own community?

Questions and Answers from the Capital Campaign Forums on May 11 and 14

1. How long can each of the projects last as is, pre-repair, i.e. roof, masonry, organ, etc.?

—The organ is in urgent need of rebuilding. We are losing notes due to the degradation of parts that control the pipes and will not be able to reliably count on the organ for our services in the next year or two. Presently of concern is the loss of bass notes more rapidly than others. Many of the pipes are not accessible by a technician unless the whole organ is removed. The boiler and elevator are both well beyond their designed service lives and need our attention. The remaining tuckpointing is less urgent than the work done on the belltower but some areas should be addressed in the next few years. The interior sanctuary work is not as time-sensitive but should be addressed as soon as possible to prevent damage from crumbling plaster to the pews and interior of the sanctuary.

2. What kind of investment should be used to grow the \$465,000 that we currently have while the fund is not deployed, allowing for financial growth of what we have?

—If this is in reference to the Investment Reserve Fund, it is already invested in the Pooled Investment Fund. Funds raised in the capital campaign can be invested and earn interest until needed to cover invoicing for the proposed building projects.

3. What kind of discount or donation can the contractors or vendor companies give us?

—All contracts will be negotiated to provide the best possible pricing for quality work. We don't expect donations but will explore any possible discounting.

4. How will projects be prioritized?

—Based on the survey results and demonstrated need

5. Are all projects to be done at once or in order of priority?

—In order of priority and availability of contractors for the specific work

6. Labor being the largest aspect of any project, is there any place where parishioners can volunteer? Where could thrifty salvage, reuse, and a DIY spirit be part of this undertaking?

—Volunteers are needed during the capital campaign. However, for insurance and liability reasons, the capital projects must be completed by professional contractors.

7. Do we plan to replace all the heating system piping?

—More studies need to be completed. We will examine all possible opportunities for efficiency and site-specific alternatives.

8. Is there an efficiency comparison for the heating system? Hot water vs. steam?

—See answer above.

9. There are generally hidden surprises when projects are undertaken. What kinds of things might be lurking? How do those things fit into the picture?

—All contracts will anticipate and include contingencies for unexpected issues that may arise during the work. This is how we contracted for the belltower repairs. Any significant cost overages will be dealt with as they arise, and we will work with the Finance Committee and Vestry to determine the best solutions.

10. Will we invest the donated funds until each project can be undertaken?

—Yes, the donations will be put into the Heritage Fund within the Pooled Investment Fund and drawn on as needed.

11. What is the cost comparison of a new organ vs repairing our organ?

—A new organ is double the cost of repairing our organ.

The Way of Love in Our Backyard

St. Paul's has labored in shared ministry with Chum, Loaves and Fishes, Damiano Center, and more for many years as we care for our less fortunate neighbors, and it's time to share that message with our more fortunate neighbors as well. At a City Planning Commission meeting the evening of Tuesday, May 13, a discussion that lasted several hours resulted in Stepping On Up and Vineyard Church gaining unanimous approval to operate Safe Bay in Vineyard's back parking lot. It quickly became clear that a couple dozen neighbors opposing the permit were doing so from perceptions of threats that have not been realized in the two years since this program began operating at Damiano Center.

Safe Bay offers people who are homeless and living out of their vehicles a safe place to park overnight (6 pm – 8 am), access to the church for restroom and shower facilities, Wi-Fi, a place to charge their electronics and to take shelter during storm events. Many of these folks are homeless for the first time. Many are working. Many are families, including children. ALL are just looking for a good night's sleep. Right now it's legal for anyone to park and sleep on any street in Duluth, as long as the vehicles is moved every 24 hours. This is already happening every night, and we are trying to support these folks by offering a secure, staffed place to stay with access to a few basic services. Fears expressed by the neighbors present included: needles everywhere, trash in their backyards, trespass, feces,

pets roaming, drawing bears to the area, noise, lights, and sexual assault. This criminalization of homelessness is rooted in fear and a lack of knowing who the people are that we serve. I volunteer for Safe Bay, and what I witness is a group of friendly, appreciative people trying to survive as they seek stable hous-



ing. We need to shift this narrative in our neighborhoods.

Join us on **Friday, June 13**, at 6:30 pm in the Parish Hall for a simple meal and discussion together as we watch the movie **Under the Bridge: The Criminalization of Homelessness**. Working together with other congregations in our neighborhood, we hope to share concerns around public safety for everyone and grow in understanding of the challenges we face as a community in light of poverty and homelessness impacting our community.

Reflections on a Year of Growth


Hello Dear Reader.

Wear Orange to End Gun Violence




Saturday, June 7, 6:00 pm, by the marine museum.



We will once again celebrate Lake Superior Sunday together with St. Andrew's by the Lake! Join us for beach church, a relaxed Eucharist on the shores of the Greatest of the Lakes. Bring a chair or blanket to sit on. Note, we will start the service at 9:45 am, which is St. Andrew's typical start time. (This allows us to time our arrival with the bridge). Carpooling from St. Paul's is encouraged. Since the beach is not accessible for folks with limited mobility, our 8:00 am service will be held at St. Paul's for anyone who cannot join us. If it rains, or conditions do not allow for beach church, we will worship in St. Andrew's sanctuary.
